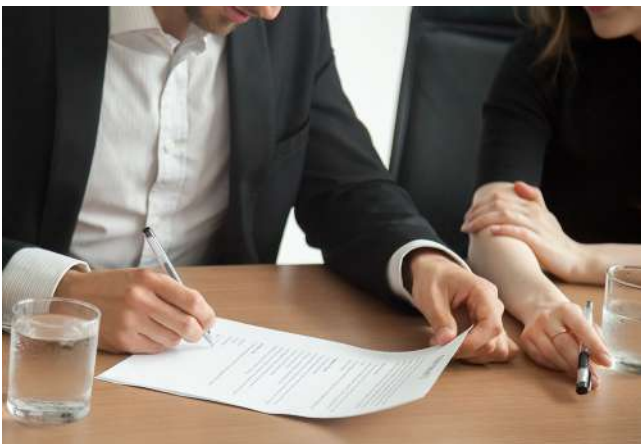
Regional and international arbitration
